RE: MANITOBA HYDRO 2017/18 & 2018/19 GENERAL RATE APPLICATION – MINIMUM FILING REQUIREMENTS AND OTHER MATTERS

On May 26, 2017, Manitoba Hydro filed responses to Minimum Filing Requirements ("MFRs") from the Public Utilities Board of Manitoba ("PUB"), the Consumers Association of Canada (Manitoba)/Winnipeg Harvest ("COALITION") and the Manitoba Industrial Power Users Group ("MIPUG"), and indicated that it anticipated filing the remaining responses on or around June 21, 2017.

Please find enclosed responses to the majority of the remaining MFRs from the PUB and Interveners. Manitoba Hydro has attempted to provide as much information as possible to all parties by aggregating information and provided redacted responses to some of the MFRs. As directed by the PUB, Manitoba Hydro will be filing a motion seeking confidential treatment of information in the MFRs that is considered to be confidential and commercially sensitive, pursuant to Rule 13 of the PUB's Rules of Practice and Procedure. Manitoba Hydro anticipates filing additional redacted responses by the end of June.

Manitoba Hydro has also made revisions to Figure 6.14 of Tab 6. As a result of these revisions, Manitoba Hydro is enclosing a revised Tab 6 (page 22) and revised PUB MFRs 32, 39, 40 and 42. Manitoba Hydro is also enclosing an update to PUB MFR 9 to include the redacted Appendices of Manitoba Hydro's Corporate Risk Management Report, as well as an update to Appendix 7.4 to include actual monthly hydraulic generation, water conditions and extra-provincial energy exchange data for the months of April and May 2017 (Directive 5 of Order 43/13).

The information being filed today will be available on Manitoba Hydro's website (www.hydro.mb.ca) as of noon Thursday, June 22, 2017.
