This email is to advise all participants that MKO will not be filing any further material with respect to interim rates. We will take part in oral argument and it will be premised on the fact that no case has been made that Hydro will suffer any prejudice or irreparable harm if the decision on the appropriate level of rate increase is left to be determined at the conclusion of a full hearing. Further, if in fact the PUB decides that certain mitigating factors are to be put into place to shield some classes from the full effect of the rate increase it would be prejudicial to those ratepayers to pay the full increase at this time.
