**Re: Efficiency Manitoba 2020/23 Efficiency Plan – Consumers Coalition  
Corrections**

The purpose of this letter is to make minor corrections to two expert reports filed by the Consumers Coalition on December 9, 2019 and one footnote contained in information requests responses that were filed by the Consumers Coalition on December 20, 2019.

In reviewing written evidence in preparation for oral testimony, it has come to our attention that one footnote was incorrect in Dr. Patricia Fitzpatrick's report, filed as Exhibit CC-5. The correction is as follows:

- Footnote 15 should read (bolded part added): These principles were identified in the context of environmental assessment, but have merit in the design and implementation of any policy decision. **See Expert Panel Review of Environmental Assessment Processes. (2017). Building common ground: A new vision for impact assessment in Canada. Ottawa, ON: Government of Canada.**

In reviewing written evidence in preparation for oral testimony, it has come to our attention that two figures were incorrectly labeled and that one footnote contained an additional sentence in Mr. Jim Grevatt's evidence, which was filed as Exhibit CC-7. The corrections are as follows:

- Figure 5 on page 24 should be labeled: "Comparison of Combined Residential Electric Program Savings to Non-Residential Electric Program Savings".
- Figure 7 on page 26 should be labeled: "Comparison of Combined Residential Electric Portfolio Savings to Non-Residential Electric Portfolio Savings".
- In footnote 39, the last sentence of the reference should be deleted, as follows: Program Savings from Tab "PVT Electric Savings" in file "3-Year Plan Electric Portfolio Summary 21Oct2019 v1.4" provided by Efficiency Manitoba to the Coalition on November 4, 2019. Codes and Standards savings from PUB/EM 1-39 Revised. ~~Load displacement and codes and standards savings are removed.~~

In reviewing information request responses in preparation for oral testimony, it has come to our attention that one footnote was incorrect in Mr. Chris Neme's responses to Public Utilities Board Information Requests, filed as Exhibit PUB-10. The correction is as follows:

- The footnote to the response to PUB/COALITION-1, which as filed said "XX add reference XX" should instead say the following: "Consumers Energy, 2018 Integrated Resource Plan (Exhibit A-2 (RTB-2), filed with the Michigan Public Service Commission in Docket U-20165 on June 15, 2018 (<https://mi-psc.force.com/sfc/servlet.shepherd/version/download/068t000000231usAAA>))."
