

Undertaking 11: Daymark to insert a column that provides the total resource cost without the non-energy benefits for tables 27, 28, 29, and 30 from the Daymark Report

Response:

Daymark provides requested tables below by including TRC ratio without non-energy benefits included as additional column.

Daymark shows cost-effectiveness results of Efficiency Manitoba's 2020/23 Plan in Tables 27 – 30 in its Report. These tables include program administrative cost test (PACT) and total resource cost (TRC) ratios. The benefits considered by Efficiency Manitoba in TRC ratios includes both direct energy benefits and non-energy benefits (NEBs). The non-energy benefits considered by Efficiency Manitoba in its natural gas portfolio are savings related with water and GHG emissions. Whereas, electric portfolio only included non-energy benefits associated with water savings. Thus, for many bundles the NEBs were zero and thus there was no change in TRC results.
