- CAC(MPI) 1-1 Attachments A & B, and Appendices 18 21 will be filed in the CSI module only
- CAC(MPI) 1-31 Appendix 1 11 will be filed in the CSI module, with redacted versions on the public record
- PUB(MPI) 1-49 Attachment A will be filed in the CSI module only
- PUB(MPI) 1-84 Appendix 1 will be filed in the CSI module only
- b) PUB(MPI) 1-85 b) Attachment A, and PUB(MPI) 1-86 a) & b) Appendix 1 & 2 have requested production of over 500 pages of project close out reports (447 pages), change requests (87 pages), and other information.
  - At the time of filing MPI has been unable to confirm if confidential or commercially sensitive information is contained within the reports. Therefore MPI will file the material confidentially, pending a final determination of the sensitivity of the contents. This material will be circulated to all parties who have signed the MPI non-disclosure agreement. In discussions with Board Counsel it was agreed that for the purposes of the close out reports it would be sufficient to publicly file 2 larger and 1 smaller reports.
- c) CAC(MPI) 1-4 a), and PUB(MPI) 1- 40 request production of reports prepared by third parties. MPI is in the process of obtaining consent to file confidentially, from the study authors and participants. MPI will circulate confidentiality agreements for signatures once all parties have agreed to proceed.
- 3. MPI will be filing corrections to EXP Appendix 17 (per the response to PUB(MPI) 1-65 parts c & d ), and EXP Appendix 19 (related to the answer in PUB(MPI) 1-64 part b ), in a forthcoming errors and omission filing.

Finally, MPI anticipates that it will be able to file responses to PUB CSI round 1 IRs on Monday August 19<sup>th</sup>, and responses to CAC CSI round 1 IRs on Monday August 26<sup>th</sup>.
