Notice of Public Hearing and Pre-Hearing Conference

Applicant: Manitoba Public Insurance Corporation

HEARING:

The Public Utilities Board (Board) anticipates holding a public hearing of an application from Manitoba Public Insurance Corporation (MPI) for approval of rates and premiums for compulsory vehicle and driver insurance effective March 1, 2020 through March 31, 2021. The hearing would take place at the Board's Hearing Room, 4* Floor, 330 Portage Avenue, Winnipeg, MB (commencing at 9:00 a.m.) on October 7, 2019. A Pre-Hearing Conference is to be convened by the Board in its offices at 9:00 a.m. on June 27, 2019.

RATE IMPACT:

MPI is requesting approval for Basic Autopac vehicle and driver insurance rates and premiums effective March 1, 2020, until April 1, 2021. The 13-month rating period will allow MPI to align its rating year with a newly revised fiscal year-end. If approved, the application will result in 0.1 per cent increase in MPI's Basic vehicle premium revenue (in addition to the revenue impact of vehicle upgrades and an increased overall driver and vehicle oppulation).

MPI has proposed that the rate request at the time of filting be provisionally based on an interest rate forecast at fiscal year-end, and that the rate request will be updated and finalized based on an update of the interest rate forecast on September 30, 2019. MPI will file an updated rate indication and associated financial schedules in advance of the public hearing. This final rate request will be subject to testing at the public hearing, and confirmation through PUB Order.

MPI is also requesting approval of the proposed Capital Management Plan, which defines how funds in the Basic Rate Stabilization Reserve will be managed, to meet the amount to be held in reserve, as prescribed by the Reserves Regulation (76/2019).
