I can advise the following in response to Ms. Fernandes' letter:

- I have interpreted the PUB's recent procedural order as requiring Mr. Todd to be giving evidence at the hearing commencing on September 7, 2016 only with respect to the allocation of net export revenues. In fact, I wrote to Mr. Peters today, asking if it were possible to schedule the order in which the "key issues" will be dealt with at the hearing in such a way as to minimize the amount of time Mr. Todd will be required to be present so as to save the costs associated with his appearance.
- As a result, my written submissions due a week today will deal only with the creation of two classes for the ARL class.
- It is my intention that Mr. Todd's evidence at the hearing commencing on September 7, 2016 will deal only with the issue of the allocation of net export revenues and it is only on this issue that he needs to be qualified.

I trust this is helpful.
