



NOTICE OF PUBLIC HEARING TOWN OF MINNEDOSA AND HUSKY ENERGY INC. WATER AND WASTEWATER ISSUE

May 1, 2019

The Public Utilities Board (Board) intends to hold an oral hearing on a dispute between the Town of Minnedosa (Town) and Husky Energy Inc. (Husky). The hearing will be held with the following particulars, unless the parties resolve the issue in advance.

The Board also has before it the Application filed by the Town for revised water and wastewater rates dated October 30, 2017. The Board is unable to consider the Application filed by the Town until it has ruled on the ongoing dispute between the Town and Husky.

The following issues will be heard:

- 1. The amount of retroactive rate adjustment to be credited to Husky by the Town for any overpayment by Husky prior to July 2017;
- 2. The amounts owing by Husky to the Town for debenture, water and wastewater service for the period from July, 2017 to December, 2018;
- 3. Whether the Town may proceed to enforce payment, by disconnection of service to Husky or transfer of the amounts owing to Husky's property tax account, for any amounts owing by Husky to the Town for the period from July, 2017 to December, 2018; and
- 4. The amount owing by Husky to the Town for the debenture starting January 2019.
